\* RCW 59.18.300 It shall be unlawful for a landlord to intentionally cause termination of any of his or her tenant's utility services, including water, heat, electricity, or gas, except for an interruption of utility services for a reasonable time in order to make necessary repairs.

**Responsibility for Utility Charges:** Pursuant to TMC 13.16.090 all utility service accounts shall be kept in the name of the legal property owner as listed by the Yakima County Assessor's Office. The property owner shall be responsible for payment of all charges set by the Toppenish Municipal Code. Landlords requesting utility termination on services for rental property will hold the city harmless for any claims resulting from termination of those services.
