Discussion:

The city of Toppenish owns the 1911 Northern Pacific Railway depot.

In 1994 the City purchased the depot. This was done with a federal grant which required matching funds which were provided by the Yakima Valley Rail and Steam Museum Association (YVRASMA).

The focus of the museum became the Northern Pacific Railway which came through the Yakima Valley in 1884 and enabled the development of the community. Multiple artifacts and pieces of railway equipment have been obtained and now the museum is recognized nationally by rail fans. Freight cars, passenger cars and locomotives have been obtained and now the problem has been having enough space to restore and display them.

Recently the museum became aware of a state grant program for museums. Part of the grant involves a "cash" match for any grant money provided. The second part of the grant is called an "in kind" match: that value of work done or donations for acquisition, improvements, or new construction done after July 1, 2019. In 2021 the city obtained a federal grant to replace the asphalt shingle depot roof with an original appearing synthetic slate roof at a final cost of \$307,308.71. Since the roof replacement was a period correct roof, the money spent would qualify for this "in kind" match.

For any of these grants, the state requires that the organization have ownership or a lease of the property until 2040. This will require the City to extend the lease with the YVRASMA approximately 16 years. If the museum fails before then, the museum assets would be used to reimburse the state. The permission to use the "in kind" amount from the depot roof improvement would preclude the city from using it for a different Heritage Grant Program. The Heritage Capital Projects (HCP) grant program was established in 1995 and provides public access to history by supporting capital projects for history-related facilities and landscapes.

Fiscal Impact: None at this time.

Recommendation: The City has attempted to understand and clarify these agreements, leases, sub-leases,

payments, etc... Unfortunately, there are still questions to answer which indicates approval of any lease extension should be delayed until a better understanding is had

by staff.

Alternatives: 1) Do not approve. 2) Forward for further study.

Discussion:

As part of the City's effort to provide necessary development of a functional transportation network, the City shall, as required by State law (RCW 35.77.010), develop, and adopt annually a Six -Year Transportation Improvement Program (Six-Year TIP) acting as a guide for the coordinated development of the City's transportation system. The Six-Year TIP of the City specifically sets forth those projects and programs of both City and regional significance that benefit the transportation system and promote public safety and efficient multi-modal movement.

The Six-Year TIP is consistent with the City's Comprehensive Plan and can be adopted following one or more public hearings before City Council.

Projects identified in the Six-Year TIP qualify for Federal and/or State funding. The proposed plan includes all types of multi-modal transportation projects. These projects are depicted in the attached documents. The Six-Year TIP is a planning document and although it does provide high level cost estimates, scheduling projects will be coordinated with available project funding, along with associated utility projects, and timing may be adjusted accordingly.

Update of the Six-Year TIP, and subsequent submission to the State, are statutory requirements, and while our local program is not required to be fiscally constrained, the program should be realistic.

This Years's TIP update includes 16 projects. All of the projects have been reevaluated and revised with the latest information and the staff's understanding of need.

Once adopted, the updated Six-Year TIP will be submitted to Washington State Secretary of Transportation by the July 1, 2024, deadline as required by RCW.

This plan will be presented to the public during the public hearing on June 10, 2024.
