# TOPPENISH CITY COUNCIL **Regular Meeting Minutes** July 22, 2019

Mayor C. Jiménez called the meeting to order at 7:00 p.m.

### **PROCLAMATION**

Mayor C. Jiménez recited the Proclamation declaring Tuesday, August 6, 2019 as the "National Night Out" in the City of Toppenish and encouraged the public to participate.

## PUBLIC COMMENT

Christine Fry, 707 Madison Avenue, Toppenish, expressed her concern for the lack of support for the police department and the continual turn over in police officers. She stated that the police department is a vital service for the community and public safety for the people. Mrs. Fry encouraged Council to support the police department in the same manner it supports other City departments.

Marcus Weible, Toppenish Police Officer, inquired why Council is not rebuilding the same type of public works building that was burned down. He stated that he and the other officers are out in the community and they see the needs of the residents, who are unable to currently afford their utility bills, let alone an increase in order to pay for a new public works building.

Motion carried unanimously.

#### **NEW BUSINESS**

Resolution 2019-28: Approving the Public Works Shop Building Funding Strategy and Authorizing the City Manager to Implement this Strategy.

CM Hoyt updated Council on the proposed resolution to approve the rebuilding and expansion of the new public works shop facility. He summarized the three options that include 1. Rebuilding a

similar sized building on the existing site, 2. Demolishing all buildings on the existing site and rebuilding a larger building, and 3. Purchasing and developing a new site to accommodate a larger building. The Council expressed their concerns that it appears that the City is proposing to rebuild something the City is unable to afford. CM Hoyt responded that the proposed resolution is to continue the process to assure the insurance company that the City is moving forward with rebuilding, in order for the City to be granted an extension of the two-year timeline as to lose the remaining insurance proceeds because the building has not been rebuilt within the required two-year time frame.

Councilmember Thorington moved, seconded by Councilmember Belton to adopt Resolution 2019-28. Motion carried with five yes votes and two no votes. Mayor C. Jiménez and Councilmember Duval voted no.
