Mayor C. Jiménez read Ordinance 2019-06 into the record: An Ordinance Amending Section 5.01.120(B) of the Toppenish Municipal Code Authorizing Business License Fees for Businesses Required to be Licensed.

CM Hoyt updated Council that proposed Ordinance 2019-06 is to amend Section 5.01.120(B) of the Toppenish Municipal Code to add language for the base rate per business plus an amount per employee to be consistent with Council's direction.

Councilmember Thorington moved, seconded by Councilmember Oaks to adopt Ordinance 2019-06. Motion carried unanimously.
